The information appearing below describes how we collect, use and disclose personal information of the users of our Site ("**Privacy Policy**") and constitute an electronic record in terms of the Information Technology Act, 2000 and applicable Rules thereunder and the provisions pertaining to electronic records in various statutes as amended by the Information Technology Act, 2000. Being generated by a computer system, the Privacy Policy does not require physical or digital signatures.

In the Privacy Policy, the terms "we", "us" and "our" refers to the author of the Site and the terms "user", "you" and "your" shall mean any person who visits the Site.

1. Collection of Information

Data
